

20. **APPROVE ACTIVITY REIMBURSEMENT SCHEDULE FOR CLUB ADVISORS FOR 2015-2016**

Recommendation of Superintendent Gregory D. Nickoli, that advisors attending authorized club activities away from Pioneer and Pioneer Satellite Schools be reimbursed for expenses, in accordance with Board-adopted policy, for attending professional meetings, and that advisors to each club be paid according to the amount indicated below:

Advisors:

Main advisor for CTSO with more than 51 students = \$1,000

Co-advisor for every 100 students above the first 100 = \$400 per co-advisor

CTSO'S with less than 51 student = \$500

Chaperone:

Approve event outside of school day after 5 pm (at least 3-7 hours) = \$50 per event

Approved event for unscheduled workday (at least 7-12 hours) = \$100

Approved overnight event, 5 pm – 5 pm (next day) (Friday evening, Saturday, Sunday, Holiday, Summer, etc.) = \$150
