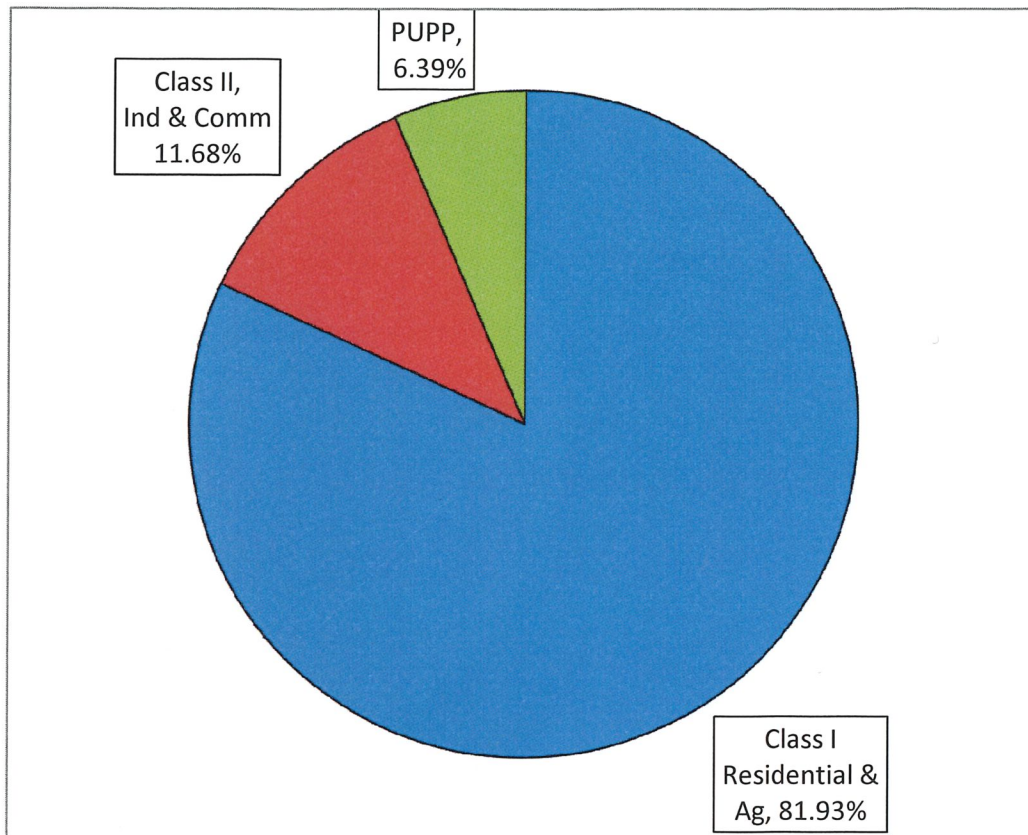

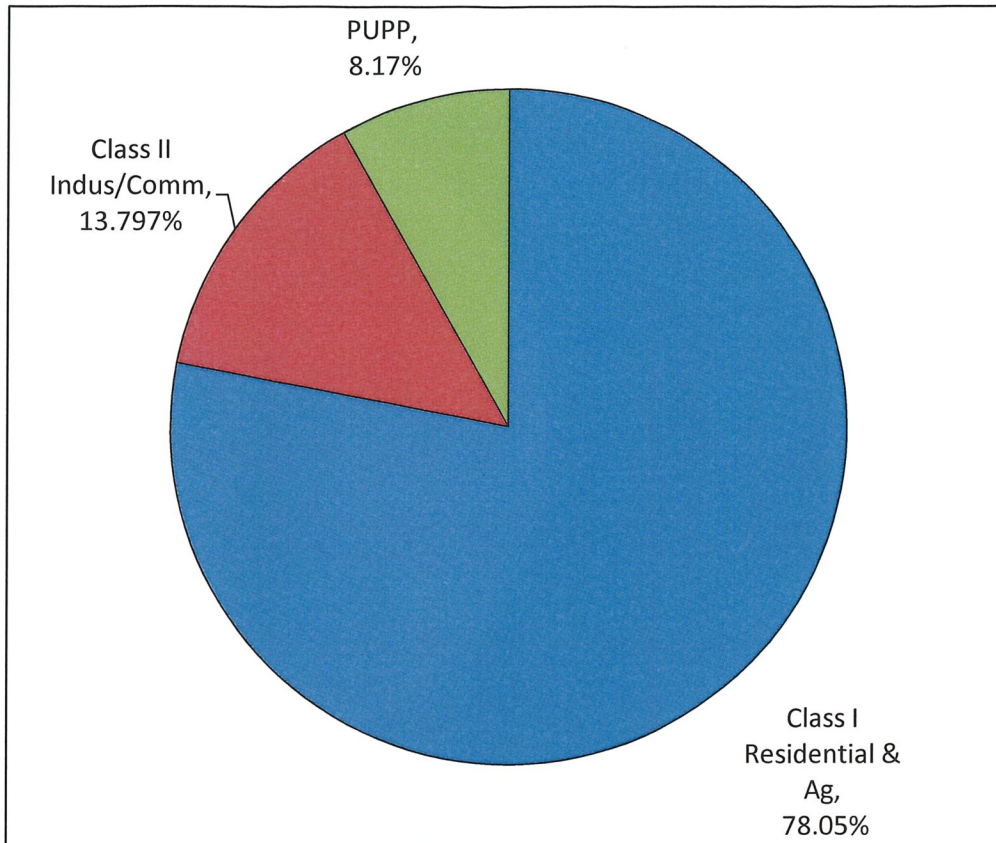

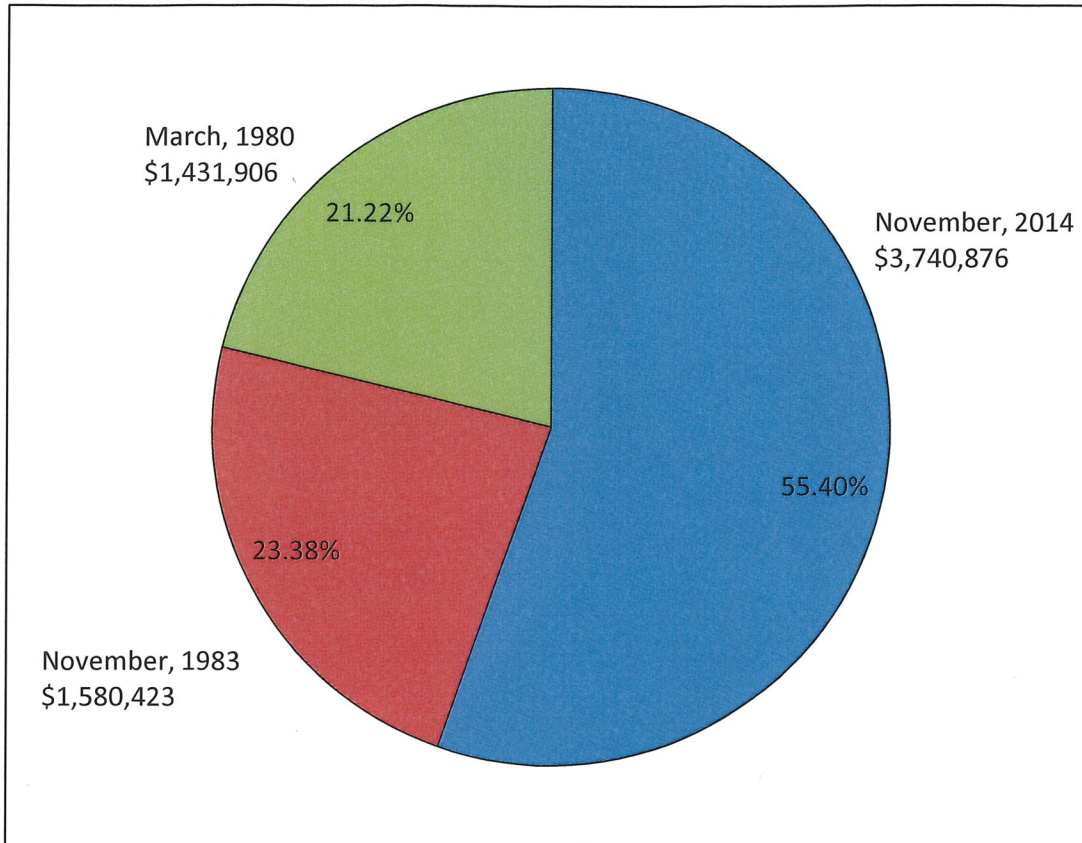


**PCTC ESTIMATED REVENUE BY CLASS**

**Collectable Year 2018**



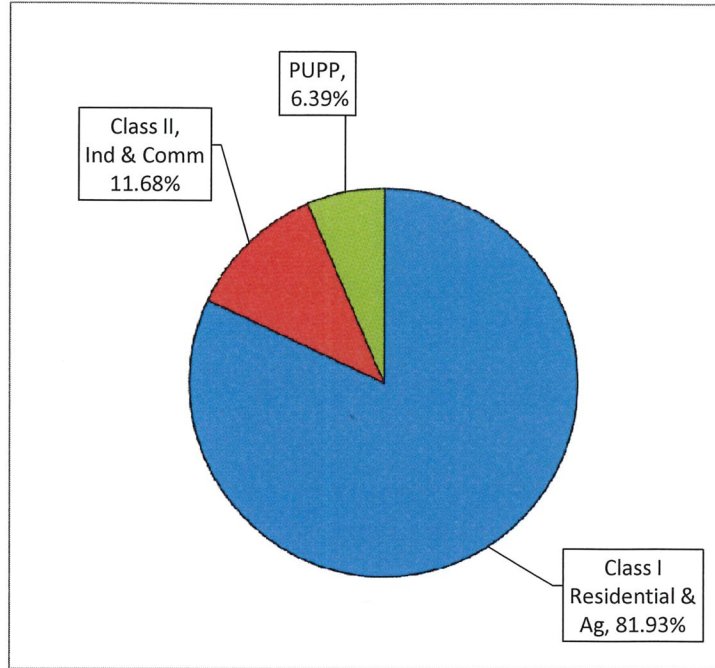

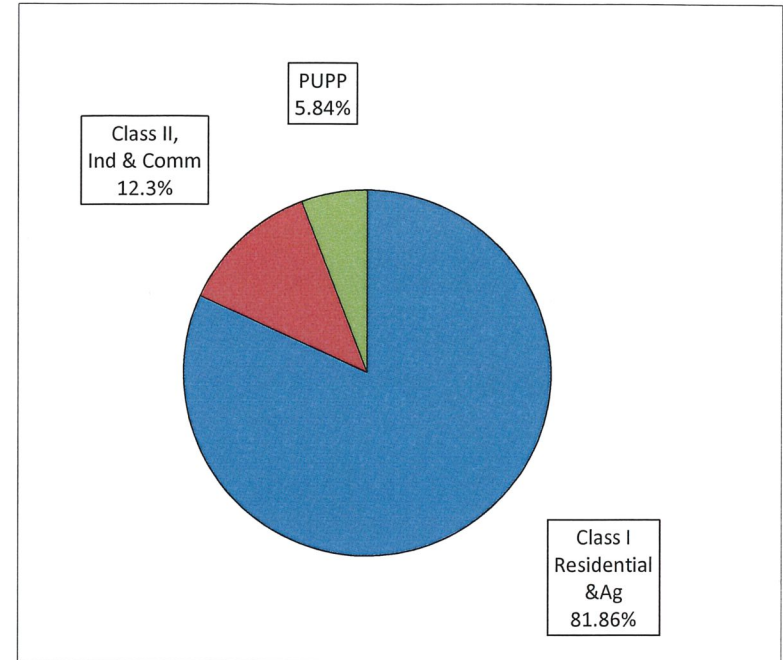

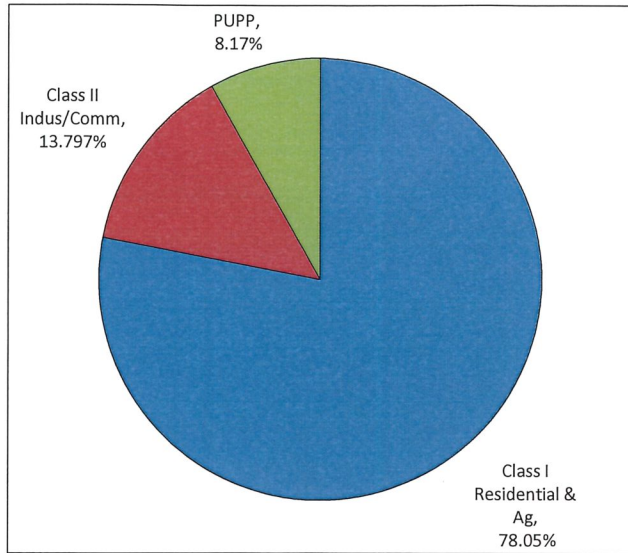

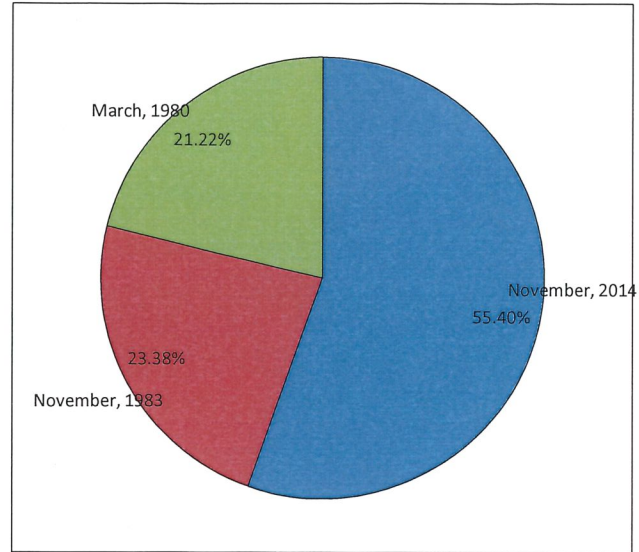
