## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is entered between the Pioneer Career and Technology Center Board of Education ("Board"), Jane Knight ("Knight") and the Education Association of Pioneer ("Association"). The sole purpose of this MOU is to reflect the parties' recognition of Knight's retirement from STRS and eligibility for a severance payment. The terms of this MOU apply to this unique situation only and will not apply to any other member of the Association. The parties understand and agree that:

- 1. Knight is a member of STKS and elected to participate in a Defined Contribution Plan pursuant to the regulations contained in Ohio Administrative Code Section 3307:2-5-02(B), which address teachers retiring under a Defined Contribution Plan.
- 2. OAC 3307:2-5-02(B) states as follows:

Application may be made for a <u>reffrencent</u> benefit by a participant who has attained at least fifty years of age, as follows: (1) <u>Reffrencent</u> shall be effective on the first of the month following the later of termination of covered teaching service or the first application for a distribution received by the retirement system. (2) Membership in the retirement system shall terminate as of the effective date of retirement. On and after that effective date, <u>the participant shall be a superannuate</u> as defined by section 3307.01 of the Revised Code as of that date. (3) Subject to the requirements of section 3307.87 of the Revised Code and Chapter 3307:2-5 of the Administrative Code, the participant shall elect on the application to take all of the balance of the defined contribution account in a lump sum payment, or to elect a plan of payment pursuant to rule 3307:2-5-09 of the Administrative Code.

- According to the attached Affidavit, Knight has fulfilled the requirements set forth in OAC 3307:2-5-02(B).
- 4. Section 811 of the Negotiated Agreement between the Board and Association describes eligibility for severance payments.
- 5. The parties agree that Knight is "eligible for retirement under the provisions set by the STRS," specifically OAC 3307:2-5-02(B). In addition, Knight meets the remaining eligibility requirements under Section 811 of the Negotiated Agreement for a severance payment.
- Considering the information set forth above, and as contained in the attached Affidavit, the Board will pay Knight a severance payment, in accordance with Section 811 of the Negotiated Agreement.
