Invoices shall be due and payable upon billing. Accounts 30 days past due will be subject to a monthly service fee of 1.5% (18% a.p.r.). Performance by Lind is contingent upon environmental and operational conditions and is subject to the terms and conditions of separate agreement(s) and licensing between Lind, applicable property lessors and regulatory authorities. Lind may substitute locations or terminate the order and refund prorata any prepaid charges to the customer without further obligation if performance is made impossible because of said agreements or relevant regulatory matters or conditions.

Lind guarantees minimum exposure days of (78) per quarter, (24) per month and (6) per week. Additional exposure, should it occur, is considered bonus activity and is not subject to this contract.
