THIS IS AN AGREEMENT between the Board of Education of the Pioneer Career & Technology Center (hereinafter referred to as "Pioneer") and the Board of Education of the Colonel Crawford Local Schools (hereinafter referred to as "Colonel Crawford LSD"), entered into in accordance with a Resolution of the Pioneer Career & Technology Center Board of Education taken on July 18, 2022 and a Resolution of the Colonel Crawford Local School District Board of Education taken on July 25, 2022.

WHEREAS, Colonel Crawford LSD has need of the services of a Food Service Coordinator; and WHEREAS, Colonel Crawford LSD has sought assistance in a collaborative effort with Pioneer in securing the provision of a Food Service Coordinator for its school district; and

WHEREAS, Pioneer has determined that it currently has a qualified Food Service Coordinator who can fulfill the duties of this position at Colonel Crawford and is willing to enter into a collaborative effort to allow both districts to more effectively and efficiently manage their resources and perform the responsibilities of the Food Service Coordinator; and

WHEREAS, Colonel Crawford, to secure the services of the Pioneer employee, wishes to reimburse Pioneer the cost for this employee to serve as Food Service Coordinator at Colonel Crawford LSD.

NOW, THEREFORE, it is mutually agreed by the parties to this Contract:

- 1 THAT Pioneer will allow the Food Service Coordinator employed by Pioneer to serve as the Food Service Coordinator of Colonel Crawford LSD commencing on or about August 1, 2022.
- THE Pioneer Food Service Coordinator will perform the duties of Food Service Coordinator for Colonel Crawford LSD, performing the duties and responsibilities for each respective district during the term of this Contract. During such time as the employee is performing duties on behalf of Colonel Crawford LSD, the employee will be subject to the direction and supervision of the Colonel Crawford LSD Board of Education or its designee.

- 3 THE referenced individual will remain at all times an employee of Pioneer entitled to such compensation and benefits afforded to the employee by Pioneer and by State law. Colonel Crawford LSD will pay to Pioneer \$25,000.00. Such payment will be billed to Colonel Crawford LSD by Pioneer on a yearly basis for services provided.
- 4 THIS contract shall remain in effect until July 31, 2023, and shall have no further force and effect beyond said period without further affirmative action by each party hereto. This action must be in writing and issued 30 days prior to July 31, 2023.
- 5 THIS Contract for Shared Services shall continue for its stated term, unless terminated by either party, with or without cause, by giving 60 (sixty) days' written notice to the Superintendent of the other district. Notice will be considered given upon receipt. The Contract may also be terminated immediately if the individual fails to perform the duties of the Job Description in each respective district, and in such event only after a meeting between the two Boards of Education or their designees to determine whether job duties are being performed and to determine whether any outstanding issues may be resolved. This latter meeting will occur within 7 (seven) days of receipt of any written request which identifies outstanding issues.
- Colonel Crawford LSD agrees that it will defend, hold harmless, and indemnify the Food Service Coordinator performing the duties under this Contract for all demands, claims, suits, and legal proceedings brought against the Food Service Coordinator in her individual or official capacity arising out of the performance of duties for Colonel Crawford LSD provided the incident arose while the Food Service Coordinator was acting within the scope of her employment (excluding criminal litigation) and any such liability is within the authority of the Colonel Crawford LSD Board to provide under State law. The Board's liability shall not exceed the amount provided by insurance purchased by the Board for this purpose of the amount appropriated by the Board, whichever is greater. Individual Board members shall not be personally liable to pay for costs arising under this paragraph.

7 THIS Contract constitutes the entire understanding of the parties with respect to the subject matter of this Contract, and it may be amended only by means of a written instrument signed by duly authorized representatives of both parties.
