

 your ad. Failure to complete the design questionnaire may
 delay the start of your campaign.
- You may update your ad on a monthly, bi-monthly or quarter basis. Please send over the appropriate sizes (see below) and specs when applicable. Please allow 1-2 days to update the ad graphics and URL if needed.



Assumptions & Client Obligations

 Pioneer Career and Technology Centerwill designate a single, dedicated point of contact with decision-making capabilities to work with our team.

- This individual will be responsible for delivering to their Richland Source/SBS contact requested content, graphics, data, company direction.
- The dedicated point of contact also agrees to responding to all communications within 24-72 hours on workdays, unless otherwise notified (and of course subject to reasonable exceptions like sickness, vacations, etc)
- You agree to keep Richland Source/SBS informed of all changes in business plans as it relates to marketing, communications, and outreach activities

- You will provide needed access to various digital assets including but not limited to: social media logins and passwords, website logins, any current analytics software used, any PPC campaign software used, etc. as necessary for your project. We will provide a full list of items required upon project launch.
- Richland Source/SBS team members will be accessible within the timeframe of workday hours as defined as 8 a.m. to 5 p.m. (EST)
 Monday through Friday. All client communication and meetings are expected to fall within this timeframe.

Terms & Conditions

- Invoicing Policy New/Returning Clients: First-month invoices will be sent 1-2 business days after contract signing, regardless of whether one-time or monthly invoicing selected. Future monthly invoicing will occur at the end of each month. All invoices have a 30-day payment expectation unless otherwise stated.
 - If your project will not begin within 30 days of contract signing, we will send your invoice the month the project will begin.
- Invoicing Policy Current Clients Renewing Contracts/Adding to
 Existing Contract: Current-paying clients with less than a 30-day gap
 of service will continue to receive monthly invoices at the end of each
 month, regardless of whether one-time or monthly invoicing selected.
- Late Payment Policy: Payment is due in full within 30 days of receipt
 of invoice unless otherwise stated or arranged. Payments exceeding
 30 days will be referred to our Billing & Collections team. Payments not
 received within 90 days of invoice will incur a monthly 2% late payment
 fee
- New Work: If there are any additional deliverables requested outside of the scope of this agreement, Richland Source/SBSwill provide an estimate for approval to Pioneer Career and Technology Center. The Agency's billable hourly rate at \$125/hour will be applied and/or the current sale rate for advertising product.
- Early Cancellation Policy: Notice of cancellation must be received in writing (email notice accepted) 30 days in advance of the official cancellation date. In the event of an early cancellation, any discounts or considerations received by Pioneer Career and Technology Center over the length of the agreement will become due in full. Projects requiring labor hours, will receive a prorated invoice for the work completed to date of cancellation.
 - Should you choose to cancel your contract early, all outstanding balances plus any monies owed through the effective date of

- your cancellation (30 days after you notify us of your intent to cancel) will become due immediately. You will receive a final statement via email and USPS of your account reflecting the above within 14 days of your notice of cancellation.
- Delays: In the case of any unreasonable or persistent delays, Richland Source/SBS reserves the right to pause the project and invoice for services rendered through the pause date based on the Agency's hourly rate (not to exceed the total amount of the fee). Richland Source/SBS will reschedule the project when Pioneer Career and Technology Center is ready to recommence, for a mutually convenient time, however, there may be additional fees or expenses required. A change order or a new agreement will be prepared.
 - One-Time Project Fees (marketing & advertising). In the scenario where Pioneer Career and Technology Centerhas a project that has already been paid in full and has not responded to any communication from Richland Source/SBS in two weeks or more, the agency reserves the right to pause the project. Depending on at which point the project has been paused, the Agency reserves the right to determine if the project shall restart. In the case that the project starts back up, the Agency will reach out to schedule a start date for a mutually convenient time; however, there may be additional fees required. A change order or new work order will be prepared for the Client to sign before the project commences once again. In the case that the project does not relaunch, the Agency will retain all fees paid unless otherwise specified in the proposal.
 - where Pioneer Career and Technology Center is contracted on a monthly retainer and has not responded to any communication from Richland Source/SBS in two weeks or more, the Agency reserves the right to pause the retainer and invoice for services rendered through the pause date based on the Agency's hourly rate of \$125 (not to exceed the total amount of the Fee). The Agency will reschedule the project when the Client is ready to recommence, for a mutually convenient time; however, there may be additional fees or expenses required. A change order or new work order will be prepared.
