The Mansfield City School District has provided on-site home/hospital instruction for a student from your school district who was admitted at the OhioHealth Mansfield Hospital Adolescent Behavioral Health Unit. Due to hospital policies and Dr. orders for this unit, patient access to internet and electronic devices is limited to the time they are in the classroom setting with the tutor.

The tuition cost for home instruction received at OhioHealth Mansfield Hospital is \$102.19 for each day services are provided. The average admitted student receives three to five days of tutoring services. Because the service is typically less than five days, we do not report changes to the student's enrollment status in EMIS and instead direct invoice per day services are provided.

The tutor will send placement information to the district for each student who enters and exits the home instruction program at OhioHealth Mansfield Hospital.

Enclosed is a contract for services for the 2023-2024 school year. Mansfield City Schools does not send individual contracts for each student served from your school district, unless specifically requested. We will send notifications when a new student has been served which will include SSID, date range, and number of days to be invoiced.

Billing invoices will be sent out at the end of the 2023-2024 school year and will include all students from your district served during the school year.


District of Attendance

This contract, in compliance with Section 3313.841 of the Ohio Revised Code, is entered into between the Mansfield City School District Board of Education and the **Pioneer Career and Technology Center**.

The Mansfield City School District agrees and binds itself to provide Home Instruction for pupil (s) in the OhioHealth Mansfield Hospital on days when school is in session. The Mansfield City Schools will provide educational services for each pupil (s) from **Pioneer Career and Technology Center**, who is enrolled in school and who comes to OhioHealth Mansfield Hospital.

The **Pioneer Career and Technology Center** Board of Education agrees to pay the Mansfield City School District Board of Education the sum of **\$102.19** per day that Home Instruction services are provided.

This contract shall be in effect for all pupils from **Pioneer Career and Technology Center** residing in the OhioHealth Mansfield Hospital during the **Pioneer Career and Technology Center** school year or until such time as terminated by either party.
