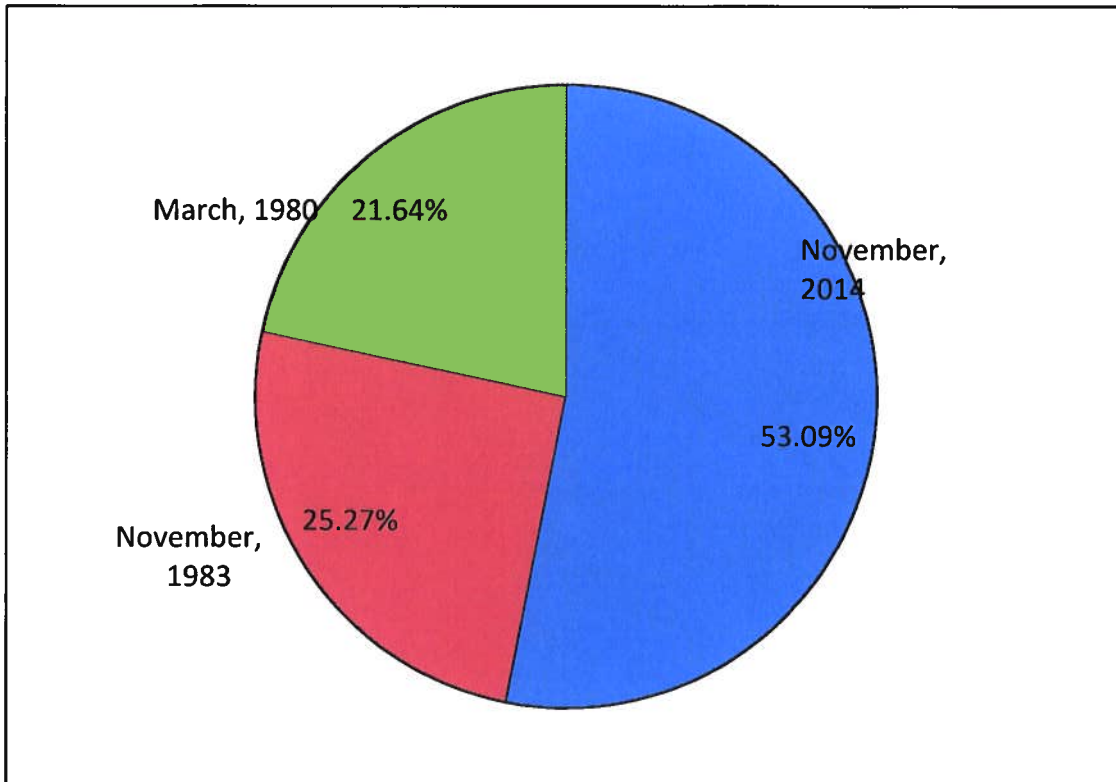

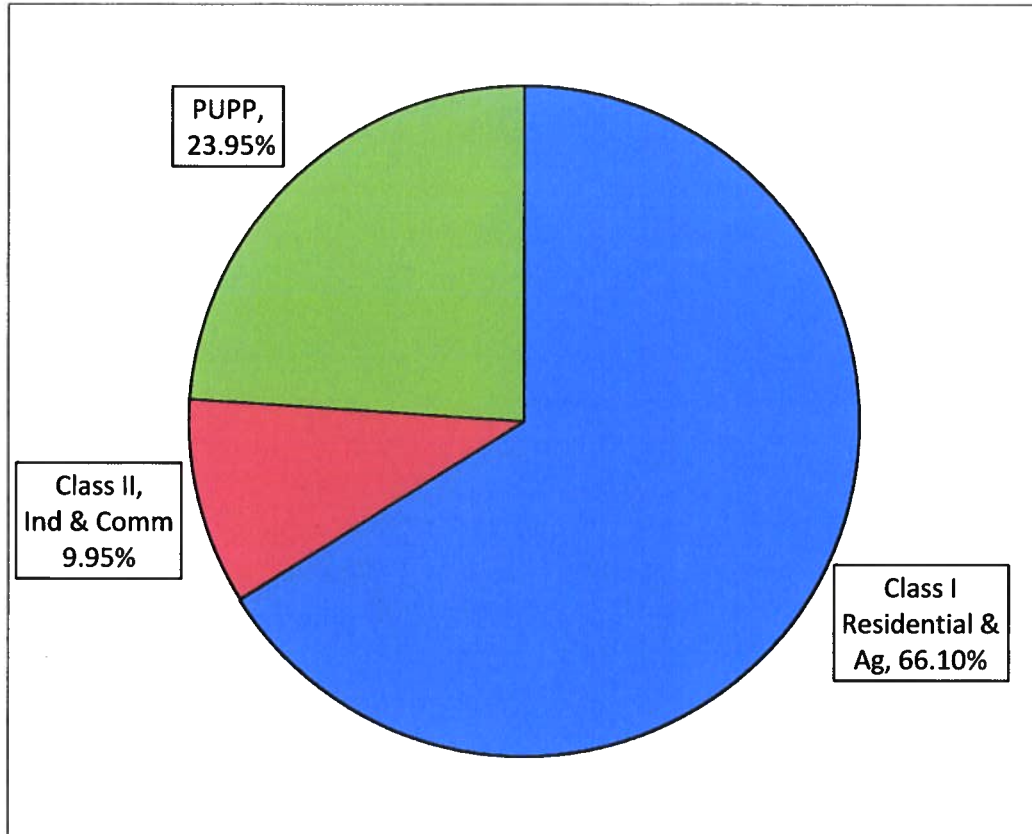

COLLECTABLE 2021**



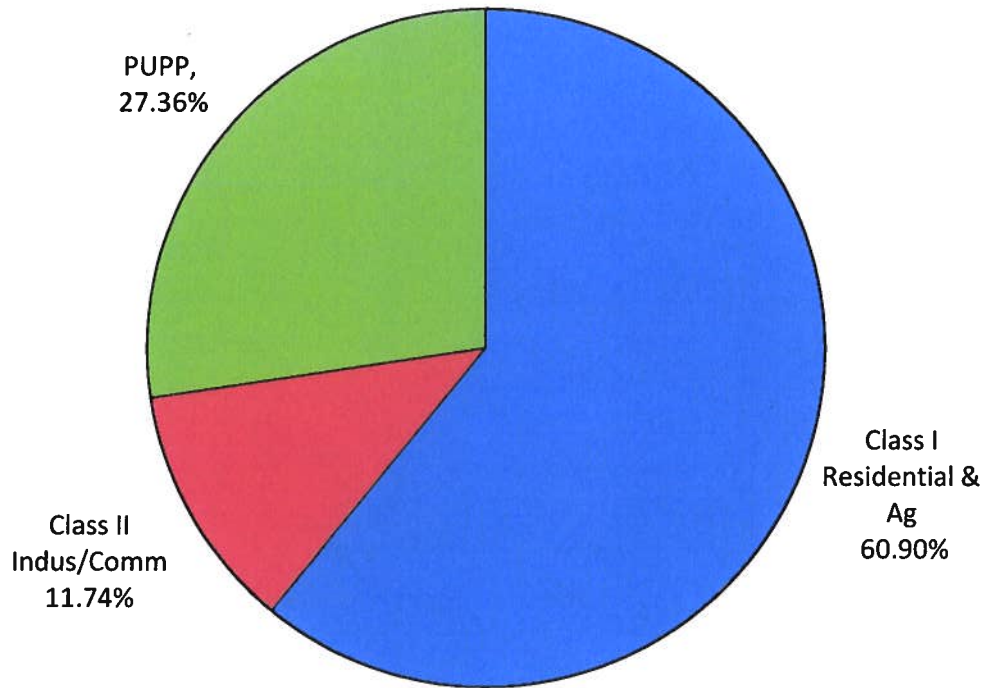

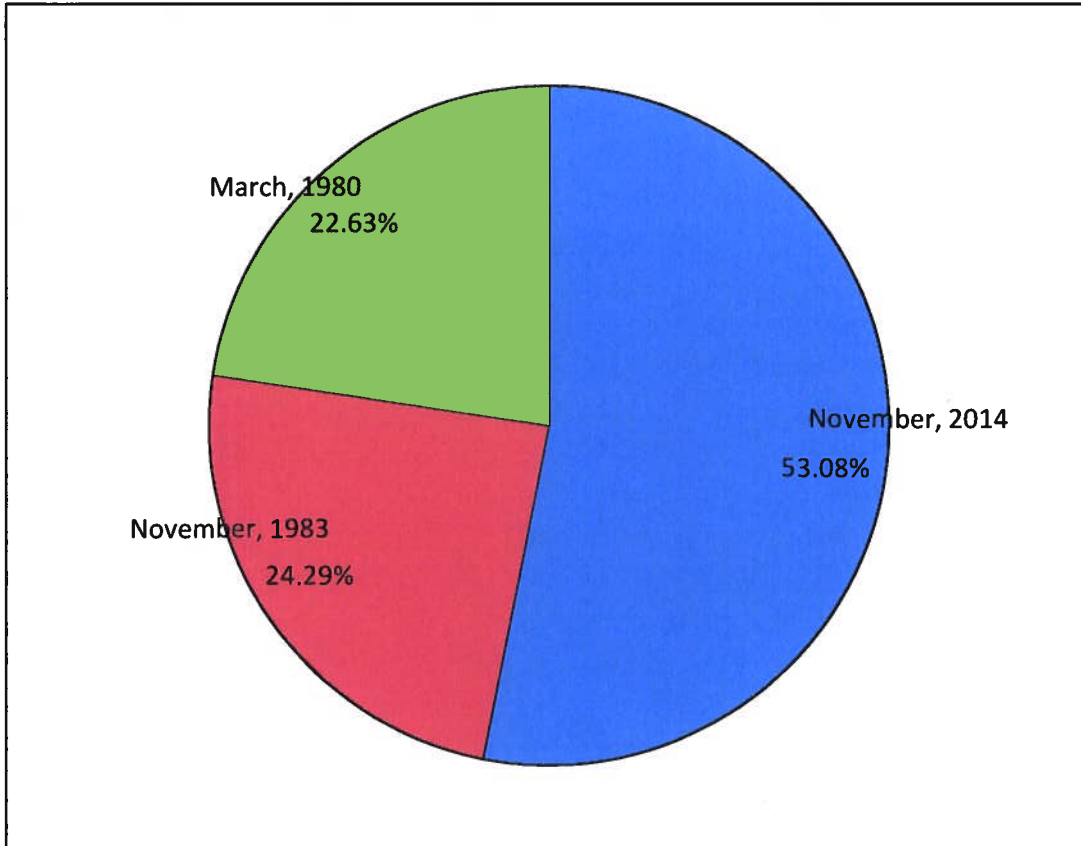

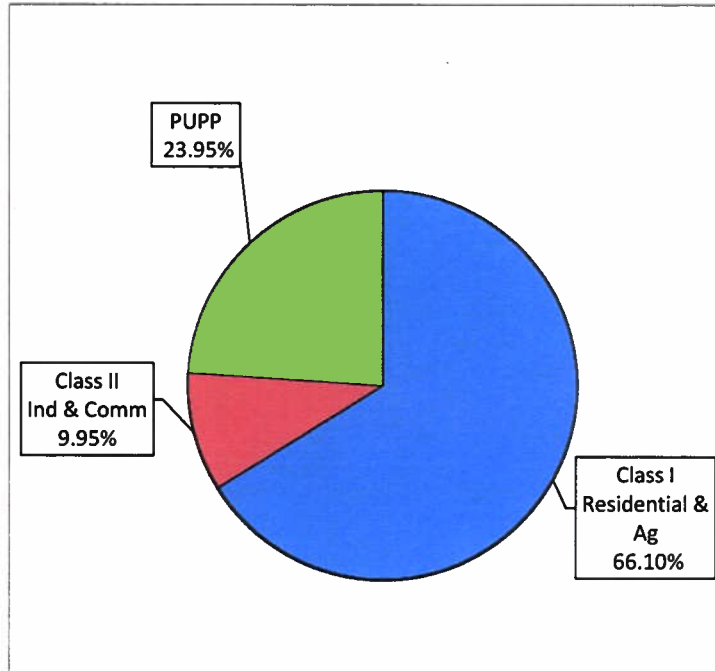

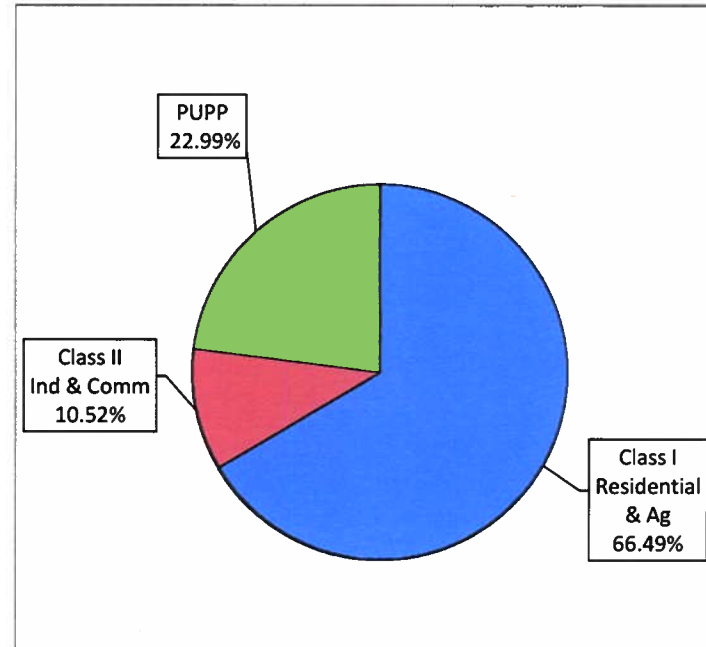

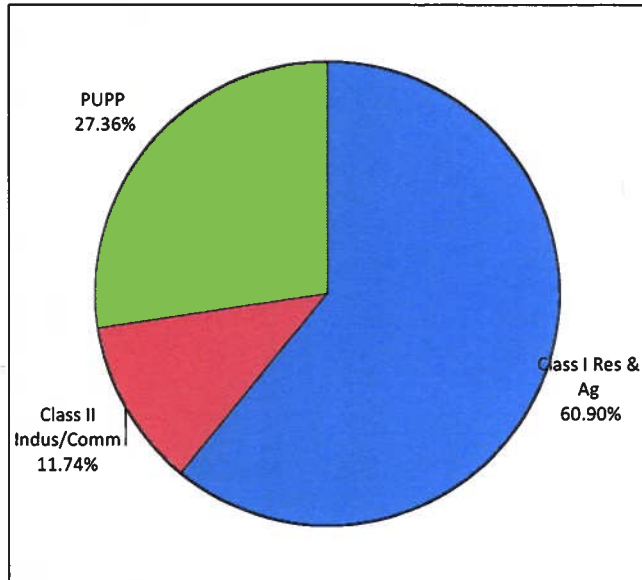

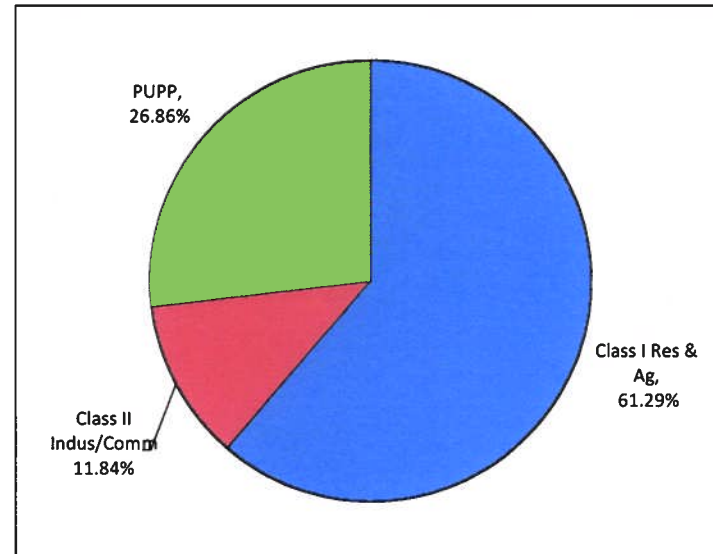

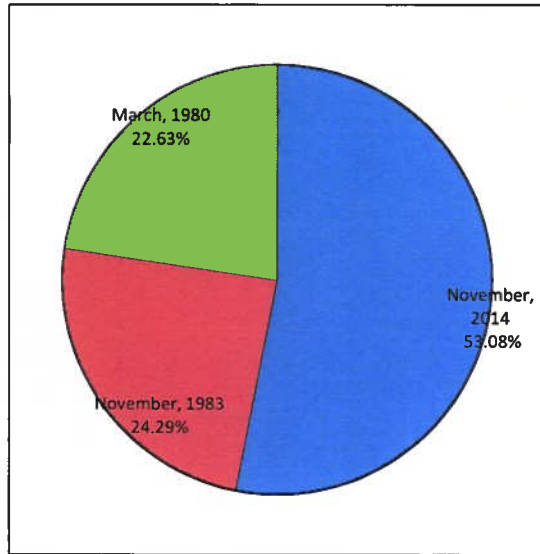

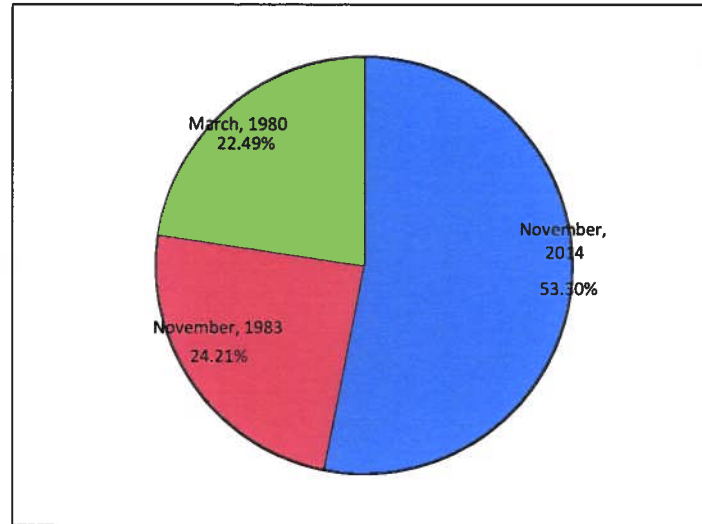
